# About us

Honouring the rich and vibrant legacy associated with this name, Pragjyotishpur University came into being on Monday, the 17th of October 2022, with the enactment of the Pragjyotishpur University Act No. XLVI of 2022 by the Government of Assam.

Pragjyotishpur University was founded with a resolve to nurture a center of world-class education and research driven by a cross-cutting approach for overcoming barriers to knowledge creation, sustenance, and dissemination. Each and every corner of this university rings with the rhythm of the true essence of **Jñāna** (knowledge), **Prajñā** (wisdom), and **Satya** (truth), three principles explicitly incorporated in the mandate of the National Education Policy (NEP, 2020). Pragjyotishpur University can accordingly be seen as a seat of learning born out of the National Education Policy (NEP, 2020).

The NEP, 2020, informs the direction of academic activities in the University, which formally began conducting classes at the Undergraduate level on 1 September 2023, for its maiden Academic Session of 2023-24. # The Sponsoring Body: SERF



The Shankardev Education and Research Foundation (SERF) is a trust formally established on Sunday, the 22nd of August 2021, at Guwahati, Assam. It is a voluntary organisation that envisions quality higher education along with inculcation of the sense of **Bhāratīya** life values in students. The SERF aims to work on two fronts for realising its objectives:

1. Developing educational institutions and
2. Collaborating with educational institutions.

As a part of its first objective, Pragjyotishpur University has come into being with the enactment of the Pragjyotishpur University Act No. XLVI of 2022 by the Government of Assam. Today, the SERF is the sponsoring body of the University.

Immediately after its establishment, the SERF, taking a step towards its second objective, conducted a series of academic deliberations and knowledge dissemination exercises. The outcome was the Two-Day North-East Education Conclave 2021, which was organised during 20 & 21 November, 2021 at Guwahati Medical College & Hospital Auditorium and at Assam Administrative Staff College, Guwahati. The conclave aimed to illustrate the basic premise of NEP, 2020, its challenges, and experiences related to its implementation in some of the major states in Bhārat.

This was the biggest Education Conclave in Northeast Bhārat in recent years and was attended by many personalities of note: among them, the Hon'ble Chief Minister of Assam, Dr. Himanta Biswa Sarma; the Union Minister for Education, Skill Development and Entrepreneurship, Shri Dharmendra Pradhan; five education ministers from the states of Manipur, Sikkim, Arunachal Pradesh, Meghalaya, and Assam; representatives of the Education Ministers of Nagaland, Mizoram, and Tripura; and resource persons from various reputed organisations such as the AICTE, the NCERT, the NCTE, the UGC, IIMs, IITs, Central Universities, Colleges, and Schools.

Going ahead, the SERF organised the Pragjyotishpur Literature Festival, 2023, an extraordinary literary extravaganza held from 29 September to 1 October 2023 in Guwahati. The LitFest aimed at familiarising and bonding the people of Bhārat with the rich literary heritage of Northeast Bhārat. It also aimed at giving the youth of the region an occasion to tap into and become more aware of their own impressions regarding their roots in their cultures and literary traditions.







# Academic Structure

## Undergraduate Programmes

### Credit

Each course offered shall carry a specified credit depending upon the quantum of work involved in the course. One credit of a course implies the quantum of work done corresponding to 1 hour of theory class or 2 hours of practical/field work or 4 hours of research every week during a semester.

Theory classes include classroom lectures and tutorials.

Credit points are calculated on the credits earned by a student and the level according to the National Credit Framework. The minimum requirement and the distribution of credits of the different modules of the undergraduate programmes are given in the following table:


# Bhāratīya Jñāna Paramparā or Indian Knowledge Systems (IKS) in Curricula

Every discipline's curriculum shall place sufficient emphasis on IKS. The course curriculum of every discipline shall include at least 5% of content about **Bhāratīyatā**, according to NEP 2020. The implementation of IKS shall follow a horizontal-cum-vertical model in the curriculum: horizontal implementation of IKS will be in the form of introduction of subjects such as **Bhārat Bodh**; vertical implementation shall come through incorporation of units/topics across discipline-specific courses in a way that establishes connections between the present-day corpus of knowledge and its parallels in IKS.

# General Guidelines for Admission

1. Candidates are required to read the prospectus carefully before filling up the application form.
2. The applicant desiring to apply in more than one course shall submit his/her preference in the same application form.
3. The candidates who have appeared in the qualifying examination but whose results have not been declared may also apply for admission. But they need to submit their results before admission. If the result of the candidate is not declared at the time of admission, his/her admission will remain provisional up to three months of admission.

## Procedures for Admission

1. Candidates seeking admission to any courses at Pragjyotishpur University during the academic session 2025-26, may obtain the application form along with the prospectus in the official website, [pju.edu.in](http://pju.edu.in), from 2 May – 30 June, 2025.
2. The admission for the new Academic Session will be started from 2 May, 2025 onwards.
3. There is no application fee required for applying for the courses in the University.

## Submission of Application Form

1. **Filled-in online application forms can be submitted through both online and offline on or before 30 June, 2025.**
2. **Online Submission Requirements:**
  - 2.1 Recent passport size-coloured photographs.
  - 2.2 Signature.
  - 2.3 Application forms should be filled in, incomplete application forms will not be accepted.
3. **Offline Submission Requirements:**
  - 3.1 Three recent (passport sizes) coloured photographs should be affixed on the application form. Photographs should be pasted with gum and should not be stapled or pinned.
  - 3.2 Candidates are required to fill the application form with his/her own handwriting.
  - 3.3 Application forms should be filled in and duly signed by the applicants.  
Incomplete application forms will not be accepted.

# Selection Procedure

Admission will be conducted on the basis of merit (percentage secured in the last qualifying examination). The admission date will be notified in the official website of the Pragjyotishpur University.

7. The Migration Certificate (when issued, if unavailable at the time of admission) issued by last board/university under/in which applicant has studied.
8. Proof of permanent address.
9. Certificate of the Extra Curricular activities such as performance in sports, culture and NCC/NSS, etc.
10. It is the sole responsibility of the candidate to ensure his/her eligibility before applying for admission to a particular programme. No claim of any shortage in this matter shall be entertained.
11. Applicants are advised to read all the instructions given in the prospectus carefully before filling up the application form.
12. All original copies of documents are to be furnished for the verification at the time of admission.

## Scholarship for Students

Pragjyotishpur University is committed to recognising and supporting the diverse talents of its students. These scholarship guidelines aim to provide a structured framework for awarding scholarships in Culture, Sports, and Youth Service (Bharat Scouts & Guides, NCC, and NSS only), ensuring fairness, transparency, and alignment with the university's mission to foster holistic development. **This scholarship is exclusively for students enrolled in general courses.**

## General Guidelines for all Scholarship Categories

### 1. Application Process:

- Interested students must submit a complete scholarship application form, available on the university website or at the office.
- The application must include all required documents, such as academic transcripts, certificates of achievement, letters of recommendation, and a personal statement outlining the applicant's goals and aspirations.
- The deadline for submitting scholarship applications will be announced annually by the university's scholarship committee.

### 2. Selection Committee:

- The selection of scholarship recipients will be made by a committee consisting of faculty members and administrators.
- The committee will review all applications and conduct interviews of shortlisted candidates.

## Scholarship Categories

### Culture (National Level)

#### 1. Eligibility:

- Applicants must be full-time students at Pragjyotishpur University.
- Applicants must have demonstrated exceptional talent and achievement in a cultural field (e.g., music, dance, drama, fine arts, literature) at the national level.
- Applicants must have represented India or a state in a national-level cultural event or competition.

## 2. Selection Criteria:

- Evaluation of the applicant's portfolio or performance demonstrating his/her cultural talent.
- Assessment of the applicant's contribution to promoting and preserving Indian culture.
- Interview to assess the applicant's passion, commitment, and future goals in his/her chosen cultural field.

## 3. Scholarship Amount:

- A fixed amount to be determined by the university's scholarship committee, covering tuition fees.

## 4. Renewal Criteria:

- Maintenance of a satisfactory academic record.
- Continuation of active participation and excellence in chosen cultural field.
- Submission of progress report detailing achievements and contributions during the scholarship period.

# Merit Scholarship

90% and above	100% of the total tuition fee for the whole course will be waived.
80% - 89%	25% of the total tuition fee for the whole course will be waived.
70% - 79%	15% of the total tuition fee for the whole course will be waived.
60% - 69%	10% of the total tuition fee for the whole course will be waived.

# Sports (District Level, State Level, National Level)

## 1. Eligibility:

- Applicants must be full-time students at Pragjyotishpur University.
- Applicants must have demonstrated outstanding athletic ability and achievement in a sport recognised by the university.
- Applicants must have represented their district in a recognised sporting event or competition.

## 2. Selection Criteria:

- Evaluation of the applicant's performance record and achievements in his/her chosen sport.
- Assessment of the applicant's potential for further development and contribution to the university's sports teams.
- Recommendation from the university's sports coaches or faculty members.



### 3. Scholarship Amount:

- A fixed amount to be determined by the university's scholarship committee, covering tuition fees.
- Additional support may be provided for participation in tournaments and competitions.

### 4. Renewal Criteria:

- Maintenance of a satisfactory academic record.
- Continuation of active participation and excellence in chosen sport.
- Adherence to the university's code of conduct.

## Youth Service (Bharat Scouts & Guides, NCC, and NSS)

### 1. Eligibility:

- Applicants must be full-time students at Pragjyotishpur University.
- Applicants must be active members of Bharat Scouts & Guides, NCC, or NSS.
- Applicants must have a proven record of community service and leadership within their respective organisations.

### 2. Selection Criteria:

- Evaluation of the applicant's service record, including the number of hours volunteered and the impact of their contributions.
- Assessment of the applicant's leadership skills, teamwork abilities, and commitment to social responsibility.
- Recommendation from the leaders or faculty advisors of Bharat Scouts & Guides, NCC, or NSS.

### 3. Scholarship Amount:

- A fixed amount to be determined by the university's scholarship committee, covering tuition fees.
- Additional support may be provided for participation in training programs.

### 4. Renewal Criteria:

- Maintenance of satisfactory academic record.
- Continuation of active involvement in Bharat Scouts & Guides, NCC, or NSS.
- Demonstration of ongoing commitment to community service and leadership.
- Submission of report outlining service activities and achievements during the scholarship period.

These guidelines are subject to periodic review and may be revised by the university's scholarship committee to ensure their effectiveness and relevance.



# Code of Conduct for Students

The Pragjyotishpur University (PU) Student Code of Conduct states, for the information of the University's students and staff (teaching/non-teaching), the standards of behaviour that students are expected to uphold. It also states the rights and the duties that come with being a student of this institution.

## Prohibited Conduct

- Cheating, which is the intentional use of unauthorised sources of information and provision or receipt of unlawful assistance for any form of professional activity, including actions that are expressly forbidden by the teacher in the course syllabus or presentation.
- Plagiarism, which entails the unauthorized copying of someone else's language, structure, images, ideas, or thoughts and passing them off as one's own without due recognition, especially in the context of work that is being submitted for credit.
- Unauthorized possession or transfer of academic materials including unauthorized sale or acquisition of exams, class notes, papers, or other academic materials.
- Assisting another individual in committing an act of academic misconduct.
- Verbally or physically abusing peers or staff.
- Committing acts of violence or endangering the physical well-being of individuals, including oneself, or animals, either through direct harm or by engaging in actions that could potentially cause bodily harm.
- Damage to institutional property or property of others.
- Involving oneself in conduct that interrupts or obstructs teaching, classroom dynamics, or any other educational engagements.
- Taking part in or promoting any demonstration, riot, or action that interferes with the normal operations of the university, limits the ability to move freely, or violates the rights of fellow members of the university community.
- Misuse or possession of alcohol or drugs.
- Utilization of substances leading to a state that jeopardizes the safety of oneself or others.
- Sexual misconduct that is violative in nature.
- Stalking.
- Unauthorized possession of university property or the property of others, including theft or attempted theft, is strictly prohibited.
- Unauthorized possession, duplication, or use of keys or access devices belonging to the University.
- Improper removal or misuse of any document, record, data, nonpublic information, identification, educational material, or property from the University is strictly prohibited.


